REPORT OF CONFERENCE COMMITTEE

MR. PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 2634: Memorial highways; designate segment in Shannon, Lee County, as the "Johnny R. Patterson Memorial Highway."

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.

2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

7 <u>SECTION 1.</u> (1) The segment of Mississippi Highway 446 8 located in Bolivar County, Mississippi, extending for a distance 9 of approximately one (1) mile in the easterly direction from its 10 point of intersection with Shaw-Skene Road to its point of 11 intersection with Gilbert Road, is designated and shall be known 12 as the "H.M. "Mack" Grimmett Memorial Highway."

13 (2) The Mississippi Department of Transportation shall erect
14 and maintain appropriate signs along and approaching the segment
15 of highway described in subsection (1) of this section.

16 **SECTION 2.** (1) The segment of Mississippi Highway 28 17 located in Soso, Jones County, Mississippi, extending for a 18 distance of approximately one (1) mile in the northwesterly 19 direction beginning at its intersection with Margay Road to a point of termination at its intersection with Mississippi Highway 20 24/HR26/SB2634CR.1J (S)HI (H)TR PAGE 1 G1/2 (DJ/KW)

21 29, is designated and shall be known as the "Paul Holifield

22 Memorial Highway."

(2) The Mississippi Department of Transportation shall erect
 and maintain appropriate signs along and approaching the segment
 of highway described in subsection (1) of this section.

26 **SECTION 3.** This act shall take effect and be in force from 27 and after July 1, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
