HOUSE CONCURRENT RESOLUTION NO.

1 A CONCURRENT RESOLUTION APPLYING TO THE UNITED STATES CONGRESS TO CALL A CONVENTION OF THE STATES UNDER THE PROVISIONS OF ARTICLE V OF THE CONSTITUTION OF THE UNITED STATES FOR THE PURPOSE OF PROPOSING AN AMENDMENT TO THE CONSTITUTION TO SET A 5 LIMIT ON THE NUMBER OF TERMS THAT A PERSON MAY BE ELECTED AS A 6 MEMBER OF THE UNITED STATES HOUSE OF REPRESENTATIVES AND TO SET A 7 LIMIT ON THE NUMBER OF TERMS THAT A PERSON MAY BE ELECTED AS A 8 MEMBER OF THE UNITED STATES SENATE. 9 WHEREAS, the Legislature of the State of Mississippi hereby makes an application to Congress, as provided by Article V of the 10 11 Constitution of the United States of America, to call a convention 12 limited to proposing an amendment to the Constitution of the United States of America to set a limit on the number of terms 13 14 that a person may be elected as a member of the United States 15 House of Representatives and to set a limit on the number of terms 16 that a person may be elected as a member of the United States 17 Senate. WHEREAS, the Secretary of State is hereby directed to 18 19 transmit copies of this application to the President and Secretary 20 of the Senate of the United States and to the Speaker, Clerk and 21 Judiciary Committee Chairman of the House of Representatives of \*HR31/R301.1\*

- 22 the Congress of the United States, and copies to the members of
- 23 the said Senate and House of Representatives from this state; also
- 24 to transmit copies hereof to the presiding officers of each of the
- 25 legislative houses in the several states, requesting their
- 26 cooperation.
- 27 WHEREAS, this application shall be considered as covering the
- 28 same subject matter as the applications from other states to
- 29 Congress to call a convention to set a limit on the number of
- 30 terms that a person may be elected to the House of Representatives
- 31 of the Congress of the United States and the Senate of the United
- 32 States; and this application shall be aggregated with same for the
- 33 purpose of attaining the two-thirds (2/3) of states necessary to
- 34 require Congress to call a limited convention on this subject, but
- 35 shall not be aggregated with any other applications on any other
- 36 subject.
- 37 WHEREAS, this application constitutes a continuing
- 38 application in accordance with Article V of the Constitution of
- 39 the United States of America until the Legislatures of at least
- 40 two-thirds (2/3) of the several states have made applications on
- 41 the same subject.
- 42 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
- 43 OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the
- 44 Legislature of the State of Mississippi applies to Congress, under
- 45 the provisions of Article V of the Constitution of the United
- 46 States, for the calling of a convention of the states, limited to

- 47 proposing an amendment to the Constitution of the United States of
- 48 America to set a limit on the number of terms that a person may be
- 49 elected as a member of the United States House of Representatives
- 50 and to set a limit on the number of terms that a person may be
- 51 elected as a member of the United States Senate.
