JOINT RESOLUTION NO. 1

1 A JOINT RESOLUTION TO AMEND CHAPTER 2149, LAWS OF 2022, TO
2 REVISE THE COMPOSITION OF MISSISSIPPI HOUSE OF REPRESENTATIVE
3 DISTRICTS 16, 22, 36, 39 AND 41.

4 WHEREAS, in its July 2, 2024, opinion the United States
5 District Court for the Southern District of Mississippi, in the
6 case styled, *Mississippi State Conf. of the NAACP v. State Bd. of*
7 *Election Comm'rs.*, No. 3:22-CV-734, concluded that the Plaintiffs
8 had shown violations of Section 2 of the Voting Rights Act.
9 Specifically, the court found the Plaintiffs had shown one House
10 district that did not satisfy the *Thornburg v. Gingles*, 478 U.S.
11 30 (1986) framework; and

12 WHEREAS, to remedy this violation, the court recognized that
13 redistricting is primarily the duty and responsibility of the
14 State through its Legislature or other body, rather than a federal
15 court, and further stated that the Mississippi Legislature would
16 be given an opportunity to create new districts, and ultimately
17 new elections would be needed in all reformed districts; and



18 WHEREAS, on July 18, 2024, after considering options, the
19 court gave the Mississippi Legislature until the conclusion of the
20 2025 Regular Session to develop a remedial plan; and

21 WHEREAS, the Mississippi Legislature has reviewed the orders
22 of the court in the above-styled case, and prepared amendments to
23 the Mississippi State House of Representatives Redistricting plan
24 adopted in 2022, which creates a new House District wherein
25 minorities will have an opportunity to elect a candidate of their
26 choice while limiting the ripple effect to existing districts as
27 much as reasonably possible:

28 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
29 STATE OF MISSISSIPPI, That Chapter 2149, Laws of 2022, is amended
30 as follows:

31 "NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
32 STATE OF MISSISSIPPI, That the Mississippi House of
33 Representatives shall consist of one hundred twenty-two (122)
34 representatives who shall be elected from one hundred twenty-two
35 (122) single-member districts, composed as follows:

817 BE IT FURTHER RESOLVED, That partial or split precincts are
818 identified in this joint resolution by an asterisk that precedes
819 its designation within the description of a district. The
820 Chairman and Vice Chairman of the Standing Joint Legislative
821 Committee on Reapportionment shall file with the Secretary of
822 State of Mississippi the Split Precinct Block List developed in
823 conjunction with the plan contained in this joint resolution that
824 details the portions of the partial or split precincts that are
825 contained within a district by census block number, and such
826 document duly filed with the Secretary of State is hereby
827 incorporated into and shall be construed to be an integral part of
828 this joint resolution.

829 BE IT FURTHER RESOLVED, That the boundaries of the House of
830 Representatives districts described above shall be:

831 (a) The boundaries of the counties listed above as such
832 boundaries existed as of January 1, 2022; and



833 (b) The precinct boundaries along such House of
834 Representative district boundaries as the precinct boundaries are
835 contained in Census Bureau's Public Law 94-171 geographic support
836 products provided for use with the September 16 data deliveries
837 officially called the "2020 Census State Redistricting Data
838 (Public Law 94-171) Summary Files."

839 BE IT FURTHER RESOLVED, (1) That this resolution shall be
840 liberally construed to effectuate the purposes hereof and to
841 redistrict the House of Representatives districts of this state in
842 compliance with constitutional requirements. It is intended that
843 this resolution and the districts described herein completely
844 encompass all the area within the state. It is also intended that
845 such districts contain all the inhabitants in this state. It is
846 further intended that the redistricting provided for in this
847 resolution result in the creation of districts that are as close
848 to equal in population as permissible under the law. It is also
849 intended that no district shall include any of the area included
850 within the description of any other district.

851 (2) If the districts described in this resolution do not
852 carry out the purposes hereof because of: unintentional
853 omissions; duplications; overlapping areas; erroneous
854 nomenclature; lack of adequate maps or descriptions of political
855 subdivisions, wards or other divisions thereof, or of their
856 boundary lines; then the Secretary of State, at the request of the
857 Chairman or Vice Chairman of the Standing Joint Legislative



858 Committee on Reapportionment shall, by order, correct such
859 omissions, overlaps, erroneous nomenclature or other defects in
860 the description of districts so as to accomplish the purposes and
861 objectives of this resolution.

862 (3) In promulgating such orders, the Secretary of State, in
863 addition to achieving equality in the population of districts as
864 permissible under law and ensuring that all areas of the state
865 are completely and accurately encompassed in such districts, shall
866 be guided by the following standards:

867 (a) In any instance in which there is a conflict
868 between the description of a district as provided in this joint
869 resolution and the map of the House of Representative districts
870 developed by the Standing Joint Legislative Committee on
871 Reapportionment in conjunction with the adopted redistricting
872 plan, the map shall control; however, in instances in which the
873 map is inconclusive, the criteria provided in paragraphs (b)
874 through (f) of this subsection shall control any dispute or issue
875 regarding the composition of any House of Representative district;

876 (b) Gaps in the description of a district shall be
877 completed in a manner that results in a total description of the
878 district that is consonant with the description of adjacent
879 districts and results in complete contiguity of districts;

880 (c) Areas of the state included within the descriptions
881 of more than one (1) district shall be allocated to the district
882 having the lowest population;



883 (d) Areas of the state not included within the
884 descriptions of any district shall be allocated to the adjacent
885 district having the lowest population;

886 (e) In the event that the area subject to corrected
887 description or allocation as provided in paragraphs (b), (c) and
888 (d) of this subsection is of such size or contains such population
889 that its inclusion as a unit in any district would result in
890 substantial disparity in the size, shape or population of the
891 district, then the Secretary of State may allocate portions of the
892 area to two (2) or more districts; and

893 (f) In any allocation of area or correction of
894 descriptions made pursuant to this joint resolution, the Secretary
895 of State shall, consistent with the foregoing standards, preserve
896 the contiguity and compactness of districts and avoid the
897 unnecessary division of political subdivisions.

898 (4) Copies of such orders shall be filed by the Secretary of
899 State in his office and in the offices of the affected election
900 commissioners and registrars. The Secretary of State may adopt
901 reasonable rules regulating the procedure for applications for
902 orders under this resolution in the manner of serving and filing a
903 notice or copy of orders relating thereto. Upon the filing of an
904 order, the description of any affected district shall be deemed to
905 have been corrected in the manner provided in such order to the
906 full extent as if such correction had been contained in the
907 original description provided in this resolution.



908 BE IT FURTHER RESOLVED, That the redistricting of House of
909 Representatives districts and Senate districts shall be deemed to
910 be separate from each other. The invalidity of the districts of
911 one (1) house shall not affect or require the redistricting of the
912 other house.

913 BE IT FURTHER RESOLVED, That the Standing Joint Legislative
914 Committee on Reapportionment is directed to provide all
915 information necessary to assist the counties in identifying the
916 boundaries of the districts described in this resolution.

917 BE IT FURTHER RESOLVED, That the redistricting contained in
918 this resolution shall supersede any prior redistricting, and any
919 prior redistricting shall be null and void upon the date this
920 resolution is effectuated.

921 BE IT FURTHER RESOLVED, That the Joint Legislative Committee
922 on Compilation, Revision and Publication of Legislation is hereby
923 directed to see to it that this resolution is placed in the
924 editor's notes that follow Section 5-1-1, Mississippi Code of
925 1972.

926 BE IT FURTHER RESOLVED, That the Chairman and Vice Chairman
927 of the Standing Joint Legislative Committee on Reapportionment
928 shall file copies of this plan with the Mississippi Department of
929 Archives, the Secretary of State, the Clerk of the Mississippi
930 House of Representatives and the Secretary of the Mississippi
931 State Senate.



932 BE IT FURTHER RESOLVED, That if any paragraph, sentence,
933 clause, phrase or any part of this resolution is declared to be
934 unconstitutional or void or if for any reason is declared to be
935 invalid or of no effect, the remaining paragraphs, sentences,
936 clauses, phrases or parts thereof shall be in no manner affected
937 thereby but shall remain in full force and effect.

938 BE IT FURTHER RESOLVED, That in redrawing House District 22
939 and surrounding districts, an effort was made to affect the least
940 number of districts possible so as to minimize confusion for the
941 voters and the burden on local election officials in administering
942 elections.

943 BE IT FURTHER RESOLVED, That in redrawing House District 22
944 and surrounding districts, an effort was made to avoid pairing
945 incumbents against one another as much as possible.

946 BE IT FURTHER RESOLVED, That the Chairman of the House
947 Apportionment and Elections Committee, with the assistance of
948 counsel, is hereby directed to submit this resolution, upon its
949 adoption by both houses of the Legislature, to the United States
950 District Court for the Southern District of Mississippi, Northern
951 Division, in the matter styled, *Mississippi State Conference of*
952 *the National Association for the Advancement of Colored People*
953 *et. al. v. Mississippi Board of Election Commissioners, Civil*
954 Action Number 3:22-CV-734-DPJ-HSO-LHS.

955 BE IT FURTHER RESOLVED, That it is the intention of the
956 Legislature that all House elections conducted in districts



957 amended by this joint resolution, and held in 2025, be
958 administered in accordance with the following schedule:

959 **April 25**-Detailed maps and address libraries must be provided
960 to local election officials.

961 **May 19**-Qualifying begins.

962 **May 30**-Qualifying deadline.

963 **June 6**-Deadline for State Executive Committees to submit
964 names of qualified candidates.

965 **June 21**-The Uniformed and Overseas Citizens Absentee Voting
966 Act, PL 99-110, 100 Stat. 924, (UOCAVA) absentee voting begins.

967 **August 5**-Special Primary Election Day.

968 **September 2**-Special Primary Runoff Election Day.

969 **September 20**-UOCAVA absentee voting begins for general
970 special election.

971 **November 4**-Special General Election Day.

972 BE IT FURTHER RESOLVED, That * * * this joint resolution
973 shall take effect and be in force from and after it has been
974 approved by the United States District Court for the Southern
975 District of Mississippi, Northern Division in the matter styled:
976 Mississippi State Conference of the National Association for the
977 Advancement of Colored People et. al. v. Mississippi Board of
978 Election Commissioners, Civil Action Number
979 3:22-CV-734-DPJ-HSO-LHS."
