JOINT RESOLUTION NO. 202

1 A JOINT RESOLUTION TO AMEND CHAPTER 2150, LAWS OF 2022, TO
2 REVISE THE COMPOSITION OF MISSISSIPPI STATE SENATE DISTRICTS 1, 2,
3 10, 11, 19, 34, 41, 42, 44 AND 45; AND FOR RELATED PURPOSES.

4 WHEREAS, in its July 2, 2024, opinion, the United States
5 District Court for the Southern District of Mississippi, in the
6 case styled Mississippi State Conf. of the NAACP v. State Bd. of
7 Election Comm'rs., No. 3:22-CV-734, concluded that the Plaintiffs
8 had shown violations of Section 2 of the Voting Rights Act.
9 Specifically, the Court found the Plaintiffs had shown that two
10 (2) Senate districts did not satisfy the framework of Thornburg v.
11 Gingles, 478 U.S. 30 (1986); and

12 WHEREAS, to remedy those violations, the Court recognized
13 that redistricting is primarily the duty and responsibility of the
14 State through its Legislature or other body, rather than a federal
15 court, and further stated that the Mississippi Legislature would
16 be given an opportunity to create new districts, and ultimately
17 elections would be needed in all reformed districts; and



18 WHEREAS, on July 18, 2024, after considering options, the
19 Court gave the Mississippi Legislature until the conclusion of the
20 2025 Regular Session to develop a remedial plan; and

21 WHEREAS, the Mississippi Legislature has reviewed the orders
22 of the Court in the above-styled case and has prepared amendments
23 to the Mississippi State Senate Redistricting plan adopted in
24 2022, thereby creating two (2) new State Senate Districts wherein
25 minorities will have an opportunity to elect a candidate of their
26 choice while limiting the ripple effect to existing districts as
27 much as reasonably possible:

28 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
29 STATE OF MISSISSIPPI, that Chapter 2150, Laws of 2022, is amended
30 as follows:

31 "BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF
32 MISSISSIPPI, That the Senate shall consist of fifty-two (52)
33 Senators who shall be elected from fifty-two (52) single-member
34 districts, composed as follows:

523 State the Split Precinct Block List developed in conjunction with

530 BE IT FURTHER RESOLVED, That the boundaries of the senatorial

532 (a) The boundaries of the counties listed above as such
533 boundaries existed on January 1, 2022; and

534 (b) The precinct boundaries along such Senate district
535 boundaries as the precinct boundaries are contained in Census
536 Bureau's Public Law 94-171 Geographic Support Products provided

540 BE IT FURTHER RESOLVED, That:

541 (1) This joint resolution shall be liberally construed to
542 effectuate the purposes thereof and to redistrict the Senate
543 districts of this state in compliance with constitutional
544 requirements. It is the intent of the Legislature that this joint
545 resolution, and the districts described herein, completely
546 encompass all the area within the state. It is also intended that
547 such districts contain all the inhabitants in this state. It is
548 further intended that the redistricting provided for in this joint
549 resolution results in the creation of districts that are as close
550 to equal in population as permissible under law. It is also
551 intended that no district shall contain any of the area included
552 within the description of another district.

553 (2) If the districts described in this joint resolution do
554 not carry out the purposes thereof because of unintentional
555 omissions, duplications, overlapping areas, erroneous
556 nomenclature, lack of adequate maps or descriptions of political



557 subdivisions, wards or other divisions thereof, or of their
558 boundary lines, then the Secretary of State, at the request of the
559 Chair or Vice Chairman of the Standing Joint Legislative Committee
560 on Reapportionment shall, by order, correct such omissions,
561 overlaps, erroneous nomenclature or other defects in the
562 description of districts so as to accomplish the purposes and
563 objectives of this joint resolution.

564 (3) In promulgating such orders, the Secretary of State, in
565 addition to achieving equality in the population of districts as
566 permissible under law and ensuring that all areas of the state
567 are completely and accurately encompassed in such districts, shall
568 be guided by the following standards:

569 (a) In any instance in which there is a conflict
570 between the description of a district as provided in this joint
571 resolution and the map of the Senate districts developed by the
572 Standing Joint Legislative Committee on Reapportionment in
573 conjunction with the adopted redistricting plan, the map shall
574 control; however, in instances in which the map is inconclusive,
575 the criteria provided in paragraphs (b) through (f) of this
576 subsection shall control any dispute or issue regarding the
577 composition of any Senate district;

578 (b) Gaps in the description of a district shall be
579 completed in a manner that results in a total description of the
580 district that is consonant with the description of adjacent
581 districts and results in complete contiguity of districts;



582 (c) Areas of the state included within the descriptions
583 of more than one (1) district shall be allocated to the district
584 having the lowest population;

585 (d) Areas of the state not included within the
586 descriptions of any district shall be allocated to the adjacent
587 district having the lowest population;

588 (e) In the event that the area subject to corrected
589 description or allocation as provided in paragraphs (b), (c) and
590 (d) of this subsection is of such size or contains such population
591 that its inclusion as a unit in any district would result in
592 substantial disparity in the size, shape or population of the
593 district, then the Secretary of State may allocate portions of the
594 area to two (2) or more districts; and

595 (f) In any allocation of area or correction of
596 descriptions made pursuant to this joint resolution, the Secretary
597 of State shall, consistent with the foregoing standards, preserve
598 the contiguity and compactness of districts and avoid the
599 unnecessary division of political subdivisions.

600 (4) Copies of such orders shall be filed by the Secretary of
601 State in his office and in the offices of the affected
602 commissioners of election and registrars. The Secretary of State
603 may adopt reasonable rules regulating the procedure for
604 applications for orders under this joint resolution in the manner
605 of serving and filing a notice or copy of orders relating thereto.
606 Upon the filing of an order, the description of any affected



607 district shall be deemed to have been corrected in the manner
608 provided in such order to the full extent as if the correction had
609 been contained in the original description provided in this joint
610 resolution.

611 BE IT FURTHER RESOLVED, That the Standing Joint Legislative
612 Committee on Reapportionment is directed to provide all
613 information necessary to assist the counties in identifying the
614 boundaries of the districts described in this joint resolution.

615 BE IT FURTHER RESOLVED, That the redistricting contained in
616 this joint resolution shall supersede any prior redistricting, and
617 any prior redistricting shall be null and void upon the date this
618 joint resolution is effectuated.

619 BE IT FURTHER RESOLVED, That the Chairman and Vice Chairman
620 of the Standing Joint Legislative Committee on Reapportionment
621 shall file copies of this plan with the Mississippi Department of
622 Archives and History, the Secretary of State, the Clerk of the
623 Mississippi House of Representatives, and the Secretary of the
624 Mississippi State Senate.

625 BE IT FURTHER RESOLVED, That if any paragraph, sentence,
626 clause, phrase or any part of this joint resolution is declared to
627 be unconstitutional or void, or if for any reason is declared to
628 be invalid or of no effect, the remaining paragraphs, sentences,
629 clauses, phrases or parts thereof shall be in no manner affected
630 thereby, but shall remain in full force and effect.



631 BE IT FURTHER RESOLVED, That the redistricting of House of
632 Representatives districts and Senate districts shall be deemed to
633 be separate from each other. The invalidity of the districts of
634 one (1) house shall not affect or require the redistricting of the
635 other house.

636 BE IT FURTHER RESOLVED, That the Joint Legislative Committee
637 on Compilation, Revision and Publication of Legislation is hereby
638 directed to see to it that this resolution is placed in the
639 editor's notes that follow Section 5-1-3, Mississippi Code of
640 1972.

641 BE IT FURTHER RESOLVED, That the Chairman of the Senate Rules
642 Committee, with the assistance of counsel, is hereby directed to
643 submit this resolution, upon its adoption by both houses of the
644 Legislature, to the United States District Court for the Southern
645 District of Mississippi, Northern Division, in the matter styled
646 Mississippi State Conf. of the NAACP v. State Bd. of Election
647 Comm'rs., No. 3:22-CV-734.

648 BE IT FURTHER RESOLVED, That in redrawing the new Senate
649 districts and affected surrounding districts, an effort was made
650 to minimize the number of affected districts so as to reduce the
651 confusion for the voters and the burden on local election
652 officials in administering elections.

653 BE IT FURTHER RESOLVED, That it is the intention of the
654 Legislature that all Senate elections conducted in districts



655 amended by this joint resolution, and held in 2025, be
656 administered in accordance with the following schedule:

657 April 25: Deadline for delivery of detailed maps and address
658 libraries to local election officials.

659 May 19: Qualifying begins.

660 May 30: Qualifying deadline.

661 June 6: Deadline for State Executive Committees to submit
662 names of qualified candidates.

663 June 21: The Uniformed and Overseas Citizens Absentee Voting
664 Act, PL 99-110, 100 Stat. 924, (UOCAVA) absentee voting begins for
665 special primary election.

666 August 5: Special Primary Election Day.

667 September 2: Special Primary Runoff Election Day.

668 September 20: UOCAVA absentee voting begins for special

671 BE IT FURTHER RESOLVED, That this resolution shall take
672 effect and be in force from and after its approval by the United
673 States District Court for the Southern District of Mississippi,
674 Northern Division, in the matter styled Mississippi State Conf. of
675 the NAACP v. State Bd. of Election Comm'rs., No. 3:22-CV-734."
