SENATE BILL NO. 2455

AN ACT TO AMEND SECTION 63-21-30, MISSISSIPPI CODE OF 1972, TO RESTORE CERTAIN DELETED LANGUAGE CONCERNING AFFIDAVIT OF AFFIXATION; AND FOR RELATED PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 63-21-30, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 63-21-30. (1) If the legal owner of a manufactured home or
- 8 mobile home and the real property to which the manufactured home
- 9 or mobile home has become affixed, wishes to permanently retire
- 10 the title to a manufactured home or mobile home to real property,
- 11 then such owner may file or cause to be filed an affidavit of
- 12 affixation duly sworn to and acknowledged before any officer or
- 13 person authorized to administer an oath under the laws of this
- 14 state in the official records of the chancery clerk of the county,
- or in the judicial district in counties having more than one (1)
- 16 such district, in which the real property is located, which
- 17 contains or is accompanied by:

18	(a)	The	names	and	addresses	of	the	legal	owner	or

- 19 owners of the manufactured home or mobile home and real property
- 20 to which the manufactured home or mobile home has become affixed;
- 21 (b) The name of the manufacturer, the make, the model
- 22 name, the model year, the dimensions, and the manufacturer's
- 23 serial number or VIN of the manufactured home or mobile home, to
- 24 the extent such data exists;
- 25 (c) The legal description and indexing instructions of
- 26 the real property to which the manufactured home or mobile home is
- 27 or shall be permanently affixed;
- 28 (d) A statement that the party executing the affidavit
- 29 is the owner of the real property described therein;
- 30 (e) A statement that the manufactured home is to be
- 31 taxed as an improvement to the real property;
- 32 (f) A statement that either:
- 33 (i) The manufactured home or mobile home is
- 34 covered by a certificate of title that the owner shall surrender
- 35 to the Department of Revenue;
- 36 (ii) The manufactured home or mobile home is
- 37 covered by a manufacturer's statement or certificate of origin
- 38 that the owner shall surrender to the Department of Revenue; or
- 39 (iii) The manufactured home or mobile home is not
- 40 covered by a certificate of title and the owner of the
- 41 manufactured home or mobile home, after diligent search and
- 42 inquiry, is unable to produce the original manufacturer's

- 43 certificate of origin for the manufactured home or mobile home,
- 44 together with a bill of sale, paid tax receipts showing assessment
- 45 in the name of the owner for a period of not less than ten (10)
- 46 years, an installment contract reflecting the serial number or VIN
- 47 of the manufactured home or mobile home, or other due proof of
- 48 ownership acceptable to the Department of Revenue; or
- 49 (iv) If the manufactured home or mobile home is
- 50 manufactured before July 1, 1999, an affidavit of ownership
- 51 substantially similar to the affidavit provided in subsection (22)
- 52 of this section;
- 53 (g) A statement whether or not the manufactured home or
- 54 mobile home is subject to one or more security interests or liens
- 55 and if the manufactured home or mobile home is subject to one or
- 56 more security interests or liens, the name and address of each
- 57 party holding a security interest in or lien on the manufactured
- 58 home or mobile home, including each holder shown on any
- 59 certificate of title issued by the Department of Revenue, if any,
- 60 the original principal amount secured by each security interest or
- 61 lien;
- 62 (h) A lien release as to each party holding a security
- 63 interest in or lien on the manufactured home or mobile home;
- (i) A statement that:
- (i) All permits required by applicable
- 66 governmental authorities have been obtained;

- 68 manufactured home be an immovable fixture and a permanent part of
- 69 the real property; and
- 70 The wheels and axles have been removed; (iii)
- 71 A statement that the manufactured home is (i)
- 72 permanently connected to a septic or sewer system and other
- 73 utilities such as electricity, water and/or gas;
- 74 A statement that all ad valorem taxes due and (k)
- 75 payable for the manufactured home or mobile home and land on which
- 76 it is located have been paid, together with a paid receipt for the
- 77 prior year confirming the same;
- 78 If different than the owner, the name and address (1)
- 79 of a person authorized to file a certified copy of the affidavit
- 80 of affixation with the tax collector after it has been duly
- 81 recorded in the real property records;
- 82 A statement authorizing the tax collector or other
- 83 designated agent to submit the completed application to the
- 84 Department of Revenue for retirement of the title to the
- 85 manufactured home or mobile home to real property; and
- 86 Due acknowledgement of the signature of each (n)
- 87 affiant as required by Section 89-3-1 et seq. or any successor
- 88 statute.
- 89 The chancery clerk, upon receipt of an affidavit of (2)
- 90 affixation meeting the requirements set forth in subsection (1) of

this section and applicable fee to record the affidavit and 91

- 92 provide a certified copy thereof, shall record the affidavit of
- 93 affixation in the official records and shall provide a certified
- 94 copy of the recorded affidavit to the owner or other party
- 95 submitting the affidavit of affixation for recording. The
- 96 chancery clerk shall forward a copy of the recorded affidavit of
- 97 affixation to the county tax assessor in order to assist in
- 98 locating and identifying the manufactured home or mobile home for
- 99 property tax purposes.
- 100 (3) After completing the requirements in subsections (1) and
- 101 (2) of this section, the owner of the manufactured home or mobile
- 102 home, or lienholder as shown on the certificate of title pursuant
- 103 to a power of attorney from the owner of the manufactured home or
- 104 mobile home, if such lienholder is a designated agent, or the
- 105 person authorized in the affidavit of affixation, shall file a
- 106 certified copy of the recorded affidavit of affixation with the
- 107 tax collector of the county where the manufactured home or mobile
- 108 home is located for retirement of the home's title, accompanied
- 109 by:
- 110 (a) A copy of the deed or other instrument of
- 111 conveyance of legal ownership to the real property to which the
- 112 manufactured home or mobile home has become affixed conveying a
- 113 fee simple or other legal ownership interest in the subject real
- 114 property; and
- 115 (b) One (1) of the following:

135	(4) Upon receipt of the affidavit of affixation and
136	accompanying documents, the tax collector shall submit the
137	completed application for the retirement of the title to the
138	manufactured home or mobile home to the Department of Revenue.
139	(5) Upon receipt of an application containing the items

required in subsections (3) and (4) of this section, the

141 Department of Revenue shall retire the title and shall notify the 142 applicant, the lender, and authorized representative, if any, in writing at the address shown in the affidavit that the title to 143 the manufactured home or mobile home has been retired. 144 145 affidavit of affixation indicates that the manufactured home or 146 mobile home is currently covered by a certificate of origin or is 147 not covered by a certificate of title and after diligent search 148 and inquiry the owner is unable to produce the original 149 manufacturer's certificate of origin, but otherwise provides a 150 bill of sale, paid tax receipts showing assessment in the name of 151 the owner for a period of not less than ten (10) years, an 152 installment contract reflecting the serial number or VIN of the 153 manufactured home or mobile home, or other due proof of ownership 154 in a form acceptable to the Department of Revenue, or if the 155 affidavit of affixation has an attached affidavit of ownership as provided for in subsection (3)(b)(iv) of this section then the 156 157 Department of Revenue may issue a certificate of title for the 158 purpose of effectuating the retirement of title.

(6) If the legal owner of the manufactured home or mobile home whose title has been retired under this section and the real property to which the manufactured home or mobile home has become affixed, wishes to detach or sever the manufactured home or mobile home from the real property, then such owner may file or cause to be filed an affidavit of severance duly sworn to and acknowledged before any officer or person authorized to administer an oath

222	(7) If a manufactured home or mobile home whose title has
223	been retired pursuant to this section is destroyed completely or
224	otherwise becomes uninhabitable, and the legal owner of the
225	manufactured home or mobile home, and the real property to which
226	the manufactured home or mobile home was affixed, desires to
227	document the destruction or uninhabitability thereof, then the
228	owner of such destroyed or uninhabitable manufactured home or
229	mobile home may file an affidavit of destruction duly sworn to and
230	acknowledged before any officer or person authorized to administer
231	an oath under the laws of this state in the official records of
232	the chancery clerk in the county and applicable judicial district,
233	if any, in which the real property is located, which contains or
234	is accompanied by:

- 235 (a) The date and cause of destruction or 236 uninhabitability of the manufactured home or mobile home;
- 237 (b) The names and mailing addresses of the legal owner 238 of the manufactured home or mobile home and real property to which 239 the manufactured home or mobile home has become affixed;

240	(c) A description of the manufactured home or mobile
241	home including the name of the manufacturer, the model year, make,
242	width, length and the serial number or VIN of the manufactured
243	home;

- 244 (d) The book and page number or instrument number, and 245 date of recordation of the affidavit of affixation;
- (e) A statement that the party executing the affidavit is the owner of the real property described in the affidavit of affixation; and
- 249 (f) Due acknowledgement of the signature of each 250 affiant as required by Section 89-3-1 et seq. or any successor 251 statute.
- 252 (8) The chancery clerk, upon receipt of an affidavit of 253 severance meeting the requirements set forth in subsection (6) of 254 this section or an affidavit of destruction meeting the 255 requirements set forth in subsection (7) of this section and 256 applicable fee to record the affidavit and provide a certified 257 copy thereof, shall record the affidavit of severance or 258 destruction, as applicable, in the official records and provide a 259 certified copy of the recorded affidavit to the owner or other 260 party submitting the affidavit for recording and shall forward a 261 copy of the affidavit to the county tax assessor in order to 262 assist in (a) in the case of an affidavit of severance, locating 263 and identifying the manufactured home or mobile home for property

- (9) After completing the requirements in subsections (6) and (8) of this section, the owner of the manufactured home or mobile home, and the real property to which the manufactured home or mobile home has become affixed with a recorded and retired title, or the person authorized in the affidavit of severance, shall file a certified copy of the duly recorded affidavit of severance with the tax collector of the county where the manufactured home or mobile home is located for the issuance of a new certificate of title to the manufactured home or mobile home, accompanied by:
- 275 (a) An abstract of land title showing legal ownership
 276 of the manufactured home or mobile home and real property along
 277 with any unreleased mortgages, deeds of trust or other liens filed
 278 of record upon the real property;
- (b) A lien release as to the manufactured home or
 mobile home or a lienholder's statement of the names and addresses
 of any lienholders in the order of their priority; and
- 282 (c) The required fee for the certificate of title for 283 the manufactured home or mobile home.
- (10) Upon receipt of the items required in subsection (9) of this section, the tax collector of the county where the manufactured home or mobile home is located shall, for any manufactured home or mobile home for which a certificate of title would be required under Section 63-21-9, submit the completed

- (14) A manufactured home or mobile home whose title has been retired pursuant to this section shall be conveyed by deed or other real property contract and shall only be transferred or otherwise contracted together with the real property to which it is affixed, unless and until the procedures described in this section for severance or destruction and issuance of a new title The legal description in any such conveyance are followed. instrument may include a recitation that the real property includes a manufactured home or mobile home permanently affixed to the real property but such a recitation is not required.
- If the title has been retired under this section, for purposes of perfecting, realizing, and foreclosure of security interests, a separate security interest in the manufactured home or mobile home shall not exist, and the manufactured home or
