## REPORT OF CONFERENCE COMMITTEE

## MR. SPEAKER AND MR. PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1509: District Attorneys; revise salaries to certain amount below chancery and circuit courts.

We, therefore, respectfully submit the following report and recommendation:

- That the Senate recede from its Amendment No. 1.
- That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

3 CERTAIN PERCENTAGE OF THE SALARY PROVIDED TO CIRCUIT AND CHANCERY JUDGES OF THE STATE; AND FOR RELATED PURPOSES.
