HOUSE BILL NO. 20

1 AN ACT TO AMEND SECTION 23-15-719, MISSISSIPPI CODE OF 1972,
2 TO AUTHORIZE A REGISTRAR TO ALLOW A PHYSICALLY DISABLED PERSON TO
3 ABSENTEE VOTE CURBSIDE DURING THE HOURS IN WHICH THE REGISTRAR'S
4 OFFICE IS OPEN FOR ABSENTEE VOTING; TO PROVIDE THE PROCESS FOR
5 CURBSIDE ABSENTEE VOTING; TO AMEND SECTIONS 23-15-637 AND
6 23-15-735, MISSISSIPPI CODE OF 1972, TO CONFORM; TO BRING FORWARD
7 SECTIONS 23-15-627, 23-15-631 AND 23-15-697, MISSISSIPPI CODE OF
8 1972, FOR THE PURPOSE OF POSSIBLE AMENDMENT; AND FOR RELATED
9 PURPOSES.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

11 **SECTION 1.** Section 23-15-719, Mississippi Code of 1972, is
12 amended as follows:

13 23-15-719. (1) Except where the registrar has already
14 mailed a ballot with an application, upon receipt of a properly
15 completed application form by an elector qualified to vote
16 absentee as provided in this article, the registrar shall mail the
17 absent voter an absentee ballot within one (1) business day, or as
18 soon as the absentee ballot is prepared and available, containing
19 the names of all the candidates and propositions, if any, to be
20 voted on in the election. The registrar shall include with the
21 absentee ballot an official envelope that complies with the

22 provisions of Section 23-15-635, as well as information to comply
23 with Section 23-15-641(3) related to the status of the elector's
24 ballot.

25 (2) (a) When an absentee voter appears before the registrar
26 to vote, the registrar shall identify the applicant by requiring
27 him or her to present identification as required by Section
28 23-15-563, and shall then deliver the ballot to the applicant in
29 the registrar's office. After the applicant has properly marked
30 the ballot and properly folded it, he or she shall deposit it in
31 the envelope furnished to him or her by the registrar.

32 After the absentee voter has sealed the envelope, he or she
33 shall ensure the absentee application on the front of the envelope
34 is complete and shall subscribe and swear to an affidavit. The
35 affidavit shall be in the following form, which shall be printed
36 on the back of the envelope containing the applicant's ballot:

55 After the completion of the requirements of this section, the
56 elector shall deliver the envelope containing the ballot to the
57 registrar.

58 (b) A registrar may allow a physically disabled person
59 to absentee vote curbside during the hours in which the
60 registrar's office is open for absentee voting. Whenever the
61 registrar of a county, exercising his or her sound discretion,
62 determines that a physically disabled person has arrived at the
63 registrar's office in a motor vehicle to absentee vote, the
64 registrar shall identify the applicant by requiring him or her to
65 present identification as required by Section 23-15-563, and then
66 shall deliver the ballot to the disabled applicant in the
67 applicant's motor vehicle. The applicant shall cast his or her
68 ballot in secret. To ensure the secrecy of the absentee vote of
69 the disabled applicant, other passengers in the motor vehicle,
70 except the disabled applicant and any other disabled persons in



71 the motor vehicle, shall exit the motor vehicle until the disabled
72 applicant has completed the marking of his or her absentee ballot.
73 After the applicant has marked properly the absentee ballot and
74 properly folded it, he or she shall deposit it in the envelope
75 furnished to him or her by the registrar.

76 After the absentee voter has sealed the envelope, he or she
77 shall ensure the absentee application on the front of the envelope
78 is complete and shall subscribe and swear to an affidavit. The
79 affidavit must be in the following form, which must be printed on
80 the back of the envelope containing the applicant's ballot:

After the completion of the requirements of this section, the elector shall deliver the envelope containing the ballot to the registrar.

102 (3) If the voter has received assistance in marking his or
103 her ballot, the person providing the assistance shall complete the
104 following form which shall be printed on the back of the envelope
105 containing the applicant's ballot:

106 "CERTIFICATE OF PERSON PROVIDING VOTER ASSISTANCE

107 (To be completed only if the voter has received assistance in
108 marking the enclosed ballot.) I hereby certify that the
109 above-named voter declared to me that he or she is blind,
110 temporarily or permanently physically disabled, or cannot read or
111 write, and that the voter requested that I assist the voter in
112 marking the enclosed absentee ballot. I hereby certify that the
113 ballot preferences on the enclosed ballot are those communicated
114 by the voter to me, and that I have marked the enclosed ballot in
115 accordance with the voter's instructions.

126 (4) The envelope used pursuant to this section shall not
127 contain the form prescribed by Section 23-15-635 and shall have
128 printed on the flap on the back of the envelope in bold print and
129 in a distinguishing color, the following: "**YOUR VOTE WILL BE**
130 **REJECTED AND NOT COUNTED IF THIS ENVELOPE IS NOT SIGNED BY YOU AND**
131 **AN ATTESTING WITNESS IN THE BOXES ACROSS THE FLAP OF THIS**
132 **ENVELOPE.**"

133 A portion of the voter's signature extending outside of the
134 box shall not be grounds for rejecting that voter's ballot.

135 (5) The registrar shall not personally hand deliver ballots
136 to voters, except to those who personally appear in the
137 registrar's office to absentee vote and to those who curbside
138 absentee vote as provided in this section.

139 **SECTION 2.** Section 23-15-637, Mississippi Code of 1972, is
140 amended as follows:

141 23-15-637. (1) (a) Absentee ballots and applications
142 received by mail, except for fax or electronically transmitted
143 ballots as otherwise provided by Section 23-15-699 for UOCAVA
144 ballots, or common carrier, such as United Parcel Service or FedEx



145 Corporation, must be postmarked on or before the date of the
146 election and received by the registrar no more than five (5)
147 business days after the election; any received after such time
148 shall be handled as provided in Section 23-15-647 and shall not be
149 counted.

150 (b) Except as otherwise provided in Section 23-15-719,
151 all ballots cast by the absent elector appearing in person in the
152 office of the registrar shall be cast with an absentee paper
153 ballot and deposited into a sealed ballot box by the voter, not
154 later than 12:00 noon on the Saturday immediately preceding
155 elections held on Tuesday, the Thursday immediately preceding
156 elections held on Saturday, or the second day immediately
157 preceding the date of elections held on other days. At the close
158 of business each day at the office of the registrar, the ballot
159 box used shall be sealed and not unsealed until the beginning of
160 the next business day, and the seal number shall be recorded with
161 the number of ballots cast which shall be stored in a secure
162 location in the registrar's office.

163 (2) The registrar shall deposit all absentee ballots which
164 have been timely cast and received by mail in a secured and sealed
165 box in a designated location in the registrar's office upon
166 receipt. The registrar shall not send any absentee ballots to the
167 precinct polling locations.

168 (3) The Secretary of State shall promulgate rules and
169 regulations necessary to ensure that when a qualified elector who



170 is qualified to vote absentee votes by absentee ballot, either by
171 mail or in person with a regular paper ballot, that person's
172 absentee vote is final and he or she may not vote at the polling
173 place on election day. Notwithstanding any other provisions of
174 law to the contrary, the Secretary of State shall promulgate rules
175 and regulations necessary to ensure that absentee ballots shall
176 remain in the registrar's office for counting and not be taken to
177 the precincts on election day.

178 **SECTION 3.** Section 23-15-735, Mississippi Code of 1972, is
179 amended as follows:

180 23-15-735. Except for ballots voted in person or curbside at
181 the office of the registrar, absentee ballots shall not be
182 delivered in person to an absentee voter or to any other person.

183 **SECTION 4.** Section 23-15-627, Mississippi Code of 1972, is
184 brought forward as follows:

185 23-15-627. (1) Any elector described in Section 23-15-713
186 may request an absentee ballot application and vote in person at
187 the office of the registrar in the county in which he or she
188 resides. The registrar shall be responsible for furnishing an
189 absentee ballot application form to any elector authorized to
190 receive an absentee ballot. Such form shall be printed on the
191 absentee ballot envelope as provided in Section 23-15-659. Except
192 as otherwise provided in Section 23-15-625, absentee ballot
193 applications shall be furnished to a person only upon the oral or
194 written request of the elector who seeks to vote by absentee



195 ballot; however, the parent, child, spouse, sibling, legal
196 guardian, those empowered with a power of attorney for that
197 elector's affairs or agent of the elector, who is designated in
198 writing and witnessed by a resident of this state who shall write
199 his or her physical address on such designation, may orally
200 request an absentee ballot application on behalf of the elector.
201 The written designation shall be valid for one (1) year after the
202 date of the designation. An absentee ballot application must have
203 the seal of the circuit or municipal clerk affixed to it and be
204 initialed by the registrar or his or her deputy in order to be
205 used to obtain an absentee ballot. A reproduction of an absentee
206 ballot application shall not be valid unless it is a reproduction
207 provided by the office of the registrar of the jurisdiction in
208 which the election is being held and which contains the seal and
209 initials required by this section.

210 (2) Such application shall be substantially in the following
211 form for applications mailed to absentee electors:

224 () I am a member of the Merchant Marine or the American Red

228 hospital and am a citizen of Mississippi or spouse or dependent of
229 such veteran.

230 () I am a civilian attached to and serving outside of the
231 United States with any branch of the Armed Forces or with the
232 Merchant Marine or American Red Cross, and am a citizen of
233 Mississippi or spouse or dependent of such civilian.

234 () I am a citizen of Mississippi temporarily residing
235 outside the territorial limits of the United States and the
236 District of Columbia.

237 () I am a student, teacher or administrator at a college,
238 university, junior or community college, high, junior high,
239 elementary or grade school, whose studies or employment at such
240 institution necessitates my absence from the county of my voting
241 residence or spouse or dependent of such student, teacher or
242 administrator who maintains a common domicile outside the county



243 of my voting residence with such student, teacher or
244 administrator.

245 () I will be outside the county on election day.

246 () I have a temporary or permanent physical disability.

247 () I am sixty-five (65) years of age or older.

248 () I am the parent, spouse or dependent of a person with a
249 temporary or permanent physical disability who is hospitalized
250 outside his or her county of residence or more than fifty (50)
251 miles away from his or her residence, and I will be with such
252 person on election day.

253 () I am a member of the congressional delegation, or spouse
254 or dependent of a member of the congressional delegation.

255 () I am required to be at work on election day during the
256 times when the polls will be open or I am required to be on-call
257 on election day during the times when the polls will be open.

258 () I am incarcerated in prison or jail in the county where
259 I am registered to vote and have not been convicted of a
260 disenfranchising crime.

261 I hereby make application for an official ballot, or ballots,

372 for making a false statement in this application and for selling
373 my vote and violating the Mississippi Absentee Voter Law. (This
374 sentence is to be in bold print.)"

375 **SECTION 5.** Section 23-15-631, Mississippi Code of 1972, is
376 brought forward as follows:

377 23-15-631. (1) The registrar shall enclose with each ballot
378 mailed to an absent elector separate printed instructions
379 furnished by the registrar containing the following:

380 (a) All absentee voters, excepting those with temporary
381 or permanent physical disabilities or those who are sixty-five
382 (65) years of age or older, who mark their ballots in the county
383 of the residence shall use the registrar of that county as the
384 witness. The absentee voter shall come to the office of the
385 registrar and neither the registrar nor his or her deputy shall be
386 required to go out of the registrar's office to serve as an
387 attesting witness.

388 (b) Upon receipt of the enclosed ballot, you will not
389 mark the ballot except in view or sight of the attesting witness.
390 In the sight or view of the attesting witness, mark the ballot
391 according to instructions.



392 (c) After marking the ballot, fill out and sign the
393 "ELECTOR'S CERTIFICATE" in the box on the back of the envelope so
394 that the signature is across the flap of the envelope to ensure
395 the integrity of the ballot. All absent electors shall have the
396 attesting witness sign the "ATTESTING WITNESS CERTIFICATE" in the
397 box across the flap on the back of the envelope. A portion of the
398 elector's signature extending outside of the box shall not be
399 grounds for rejecting that elector's ballot. Place the necessary
400 postage on the envelope and deposit it in the post office or some
401 government receptacle provided for the deposit of mail so that the
402 absent elector's ballot will be postmarked on or before the date
403 of the election and received by the registrar no more than five
404 (5) business days after the election. The ballot may only be
405 transmitted by the United States Postal Service or other common
406 carriers, including, but not limited to, United Parcel Service or
407 FedEx Corporation.

408 Any notary public, United States postmaster, assistant United
409 States postmaster, United States postal supervisor, clerk in
410 charge of a contract postal station, or other officer having
411 authority to administer an oath or take an acknowledgment may be
412 an attesting witness; provided, however, that in the case of an
413 absent elector who is temporarily or permanently physically
414 disabled, the attesting witness may be any person eighteen (18)
415 years of age or older and such person is not required to have the
416 authority to administer an oath. If a postmaster, assistant



417 postmaster, postal supervisor, or clerk in charge of a contract
418 postal station acts as an attesting witness, his or her signature
419 in a box on the elector's certificate must be authenticated by the
420 cancellation stamp of their respective post offices. If an
421 officer having authority to administer an oath or take an
422 acknowledgment acts as attesting witness, his or her signature in
423 a box on the elector's certificate, together with his or her title
424 and address, but no seal, shall be required. A portion of the
425 elector's signature extending outside of the box shall not be
426 grounds for rejecting that elector's ballot. Any affidavits made
427 by an absent elector who is in the Armed Forces may be executed
428 before a commissioned officer, warrant officer, or noncommissioned
429 officer not lower in grade than sergeant rating or any person
430 authorized to administer oaths.

431 (d) When the application accompanies the ballot it
432 shall not be returned in the same envelope as the ballot but shall
433 be returned in a separate pre-addressed envelope provided by the
434 registrar.

435 (e) A candidate for public office, or the spouse,
436 parent or child of a candidate for public office, may not be an
437 attesting witness for any absentee ballot upon which the
438 candidate's name appears, unless the voter is related within the
439 first degree to the candidate or the spouse, parent or child of
440 the candidate.



(f) Any voter casting an absentee ballot who declares that he or she requires assistance to vote by reason of blindness, temporary or permanent physical disability or inability to read or write, shall be entitled to receive assistance in the marking of his or her absentee ballot and in completing the affidavit on the absentee ballot envelope. The voter may be given assistance by anyone of the voter's choice other than a candidate whose name appears on the absentee ballot being marked, the spouse, parent or child of a candidate whose name appears on the absentee ballot being marked or the voter's employer, an agent of that employer or a union representative; however, a candidate whose name is on the ballot or the spouse, parent or child of such candidate may provide assistance upon request to any voter who is related within the first degree. In order to ensure the integrity of the ballot, any person who provides assistance to an absentee voter shall be required to sign and complete the "Certificate of Person Providing Voter Assistance" on the absentee ballot envelope.

458 (2) The foregoing instructions required to be provided by
459 the registrar to the elector shall also constitute the substantive
460 law pertaining to the handling of absentee ballots by the elector
461 and registrar.

462 (3) The Secretary of State shall prepare instructions on how
463 absent voters may comply with the identification requirements of
464 Section 23-15-563.



465 **SECTION 6.** Section 23-15-697, Mississippi Code of 1972, is
466 brought forward as follows:

467 23-15-697. When the absentee ballot has been voted and the
468 envelope sealed, signed and certified to as provided above, the
469 absentee voter shall mail the envelope containing the ballot to
470 the registrar.

471 Hand-delivery of ballots to a voter or from a voter shall be
472 prohibited, and the use of drop boxes or other mechanisms to
473 submit a completed absentee ballot other than by mail or common
474 carrier, shall be prohibited.

475 **SECTION 7.** This act shall take effect and be in force from
476 and after July 1, 2026.
