COMMITTEE AMENDMENT NO 1 PROPOSED TO**

**House Bill No. 1934**

**BY: Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

5           **SECTION 1.** The following sum, or so much thereof as may be  
6 necessary, is appropriated out of any money in the State General  
7 Fund not otherwise appropriated, for the purpose of defraying the  
8 expenses of the Mississippi Arts Commission for the fiscal year  
9 beginning July 1, 2026, and ending June 30, 2027.....  
10 .....\$           1,948,312.00.

11           **SECTION 2.** The following sum, or so much thereof as may be  
12 necessary, is appropriated out of any money in the special fund in  
13 the State Treasury to the credit of the Mississippi Arts  
14 Commission which is comprised of special source funds and



15 donations collected by or otherwise available to the commission,  
16 for the purpose of defraying the expenses of the commission for  
17 the fiscal year beginning July 1, 2026, and ending June 30, 2027..  
18 .....\$ 7,699,838.00.

19 **SECTION 3.** Of the funds appropriated under the provisions of  
20 this act, not more than the following amount of funds, with the  
21 exception of the provisions in this section, shall be expended  
22 only for "Personal Services," which includes "Vacancy Funding,"  
23 for the following authorized number of employment headcount:

37 As used in this section, the term "Personal Services" shall  
38 mean funds provided under the major object of expenditure category



39 Personal Services for Salaries, Wages, and Fringe Benefits. Funds  
40 in this category shall not be transferred to any other category.

41 It is the intention of the Legislature to ensure compliance  
42 with the Variable Compensation Plan, as outlined in Section  
43 25-9-147, Mississippi Code of 1972. Payment from these funds  
44 shall be in accordance with the Variable Compensation Plan  
45 promulgated by the Mississippi State Personnel Board. It is the  
46 Legislature's intention that no employee's salary falls below the  
47 minimum salary established by the Mississippi State Personnel  
48 Board.

49 The State Personnel Board shall determine and publish the  
50 projected annual cost of "Personal Services" based on monthly and  
51 year-to-date payroll expenditures in compliance with the  
52 provisions of this act.

53 With the funds herein appropriated, it shall be the agency's  
54 responsibility to ensure that no single personnel action or  
55 combination of personnel actions, when annualized, exceeds the  
56 Fiscal Year 2027 appropriation for "Personal Services" with the  
57 exception of escalated funds. Further, it shall be the agency's  
58 responsibility to ensure that funds required to be appropriated  
59 for "Personal Services" for Fiscal Year 2028 do not exceed Fiscal  
60 Year 2027 funds appropriated for that purpose unless programs or  
61 positions are added to the agency's Fiscal Year 2027 budget by the  
62 Mississippi Legislature.



63           If, at the time the agency takes any action to change  
64 "Personal Services," the State Personnel Board determines that the  
65 agency has taken or will take an action that would cause the  
66 agency to exceed the funds appropriated in this act when  
67 annualized for Fiscal Year 2027 or increase the need for "Personal  
68 Services" for Fiscal Year 2028, when annualized, the State  
69 Personnel Board shall process no salary actions until such time as  
70 the requirements of the provisions of this section are met with  
71 the exception of new hires determined to be essential for the  
72 agency.

73           When used in this section, "Vacancy Funding" shall mean funds  
74 included in the Total Personal Services amount listed above and  
75 designated for approved vacancies in Fiscal Year 2027. These  
76 funds are to be utilized to increase the number of filled  
77 headcounts that were authorized but unfilled as of the last day of  
78 Fiscal Year 2026. If the agency fills additional headcounts after  
79 March 1, 2026, until the end of Fiscal Year 2026, the amount of  
80 available Vacancy Funding may be proportionally adjusted to  
81 reflect the updated number of filled headcounts. The agency shall  
82 be responsible for ensuring that "Vacancy Funding" is used to  
83 increase headcounts and not for promotions, title changes,  
84 in-range salary adjustments, or any other mechanism for increasing  
85 salaries for current employees.

86           Any transfers or escalations shall be made in accordance with  
87 the terms, conditions, and procedures established by law or



88 allowable under the terms set forth within this act. The State  
89 Personnel Board shall not escalate positions or increase the  
90 Personal Services total without written approval from the  
91 Department of Finance and Administration. The Department of  
92 Finance and Administration shall not provide written approval to  
93 escalate any funds for salaries and/or headcounts without proof of  
94 availability of new or additional funds above the appropriated  
95 level. Unless specifically noted, all Fiscal Year 2026 escalated  
96 headcounts have been accounted for and shall be converted to  
97 authorized time-limited headcounts.

98 No general funds authorized to be expended herein shall be  
99 used to replace federal funds and/or other special funds used for  
100 salaries authorized under the provisions of this act and which are  
101 withdrawn and no longer available.

102 None of the funds herein appropriated shall be used in  
103 violation of the Internal Revenue Service's Publication 15-A  
104 relating to the reporting of income paid to contract employees, as  
105 interpreted by the Office of the State Auditor.

106 If the agency's total authorized headcount decreases from  
107 Fiscal Year 2026 to Fiscal Year 2027, it will be the agency's  
108 discretion as to what headcounts are removed.

109 **SECTION 4.** It is the intention of the Legislature that the  
110 Mississippi Arts Commission shall maintain complete accounting and  
111 personnel records related to the expenditure of all funds  
112 appropriated under this act and that such records shall be in the



113 same format and level of detail as maintained for Fiscal Year  
114 2026. It is further the intention of the Legislature that the  
115 agency's budget request for Fiscal Year 2028 shall be submitted to  
116 the Joint Legislative Budget Committee in a format and level of  
117 detail comparable to the format and level of detail provided  
118 during the Fiscal Year 2027 budget request process.

119 **SECTION 5.** Of the funds appropriated under the provisions of  
120 Section 2, funds in the amount of One Million Four Hundred Ninety  
121 Thousand Dollars (\$1,490,000.00) shall be derived from the  
122 Education Enhancement Fund deposited pursuant to Sections 27-65-75  
123 and 27-67-31, Mississippi Code of 1972, for the following:

124	Training of educators and promotion of arts programs in	
125	public schools.....	\$ 100,000.00
126	Miscellaneous grants and programs.....	\$ 350,000.00
127	Whole Schools Initiative.....	\$ 1,040,000.00

128 **SECTION 6.** The following sum, or so much thereof as may be  
129 necessary, is reappropriated out of any money in the Capital  
130 Expense Fund not otherwise appropriated, for the Mississippi Arts  
131 Commission for the purpose of reauthorizing the expenditure of  
132 Capital Expense Funds as authorized in House Bill 41, 2025 First  
133 Extraordinary Session, to provide for the Building Fund for the  
134 Arts for the fiscal year beginning July 1, 2026, and ending June  
135 30, 2027..... \$3,600,000.00.

136 Notwithstanding the amount reappropriated under the  
137 provisions of this section, in no event shall the amount expended



138 exceed the unexpended balances as of June 30, 2026. In addition,  
139 this reappropriation shall not change the purpose for which the  
140 funds were originally authorized.

141       **SECTION 7.** It is the intention of the Legislature that  
142 whenever two (2) or more bids are received by this agency for the  
143 purchase of commodities or equipment, and whenever all things  
144 stated in such received bids are equal with respect to price,  
145 quality and service, the Mississippi Industries for the Blind  
146 shall be given preference. A similar preference shall be given to  
147 the Mississippi Industries for the Blind whenever purchases are  
148 made without competitive bids.

149       **SECTION 8.** It is the intention of the Legislature that the  
150 funds herein appropriated shall be expended in compliance with  
151 Section 27-104-25, Mississippi Code of 1972, that no state agency  
152 shall incur obligations or indebtedness in excess of their  
153 appropriation and that the responsible officers, either personally  
154 or upon their official bonds, shall be held responsible for  
155 actions contrary to this provision.

156       **SECTION 9.** It is the intention of the Legislature that the  
157 Arts Commission may retain an amount not to exceed one percent  
158 (1%) of the monies in the Building Fund for the Arts for the  
159 purpose of defraying administrative costs associated with  
160 administering the grant program established in Section 39-11-13,  
161 Mississippi Code of 1972.



162           **SECTION 10.** Of the funds appropriated under the provisions  
163 of Section 2, Five Million Dollars (\$5,000,000), or so much  
164 thereof, shall be derived out of any money in the State Treasury  
165 to the credit of the Capital Expense Fund, as created in Section  
166 27-103-303, Mississippi Code of 1972, and allocated in a manner as  
167 determined by the Treasurer's Office. This appropriation is made  
168 for the purpose of providing the funds necessary to authorize the  
169 expenditure of funds for the Building Fund for the Arts.

170           **SECTION 11.** Of the funds provided in Section 1 of this act,  
171 Three Hundred Twenty-three Thousand Dollars (\$323,000.00), or so  
172 much thereof as may be necessary, is provided for the MS Folklife  
173 Area at the National Folk Festival and updates to the agency  
174 website.

175           **SECTION 12.** The money herein appropriated shall be paid by  
176 the State Treasurer out of any money in the State Treasury to the  
177 credit of the proper fund or funds as set forth in this act, upon  
178 warrants issued by the State Fiscal Officer; and the State Fiscal  
179 Officer shall issue his warrants upon requisitions signed by the  
180 proper person, officer or officers, in the manner provided by law.

181           **SECTION 13.** This act shall take effect and be in force from  
182 and after July 1, 2026.
